Solar PV capacity accounted for 13.0% of total power plant installations globally in 2022, with a total recorded capacity of 1,109GW. Renewable energy is expected to contribute 30% of the global energy by the end of 2030, with installations totalling 4,002GW. Greece accounts for 0.45% of the total global Solar PV capacity. Photovoltaic installations in Western Greece have seen tremendous growth in recent years. Western Greece is an ideal area for the development of photovoltaic installations due to its plentiful sunlight and favorable environment. Greece has overtaken the Netherlands to become Europe's solar PV leader, with 19% of its electricity coming directly from the sun.
