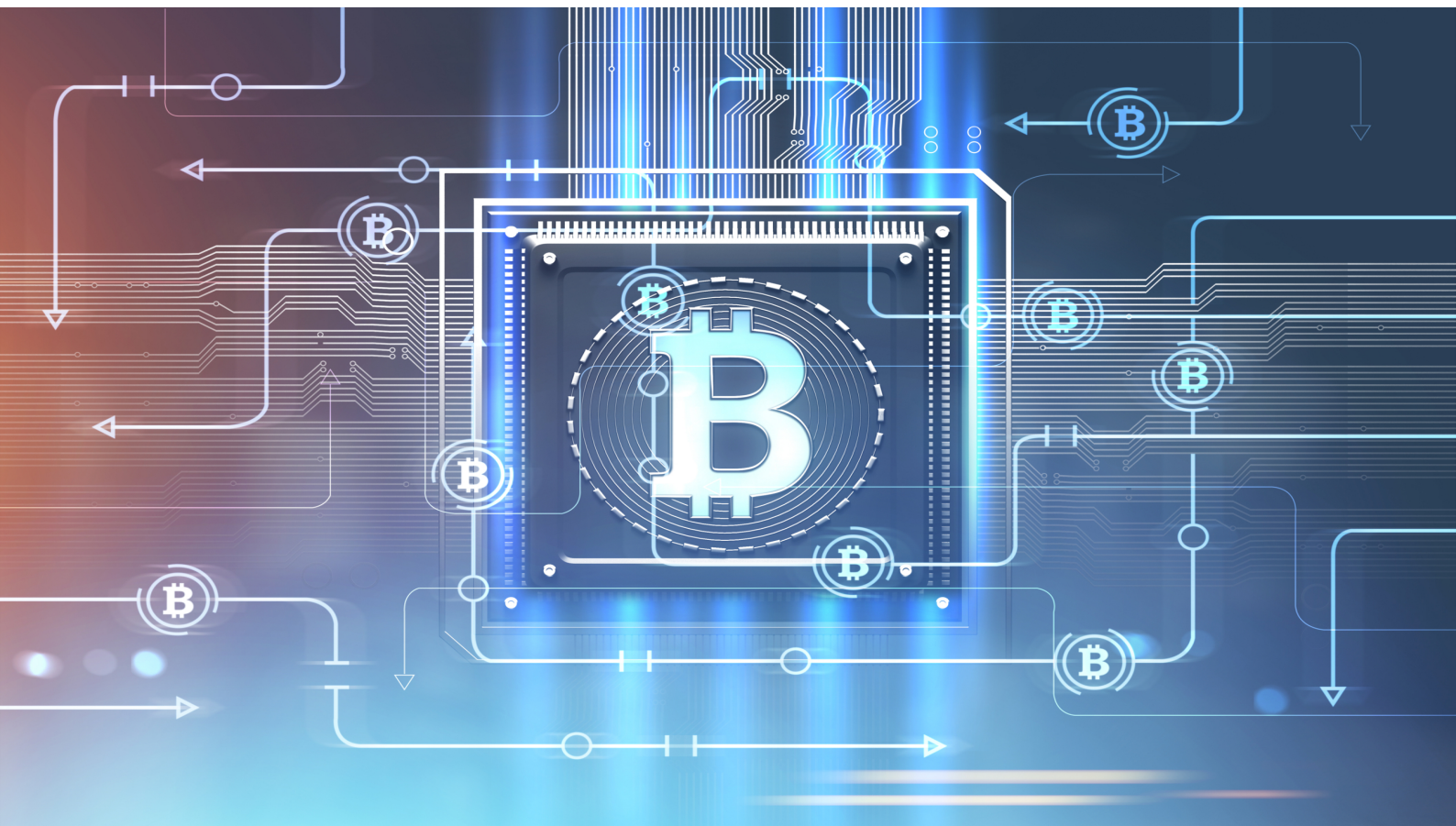

### Core Platform Components

- **Trading Terminal:** A multi-exchange interface featuring unified execution, automation, and advanced analytics.
- **Evaluation Engine:** A structured "challenge" model designed to continuously attract and onboard a global base of traders.
- **Scalable Acquisition:** A mechanism that converts user flow into monetizable activity, including hedging and proprietary strategy execution.

### Business & Monetization Model

The company utilizes a multi-layered model where user acquisition and platform access support a primary trading-driven engine:

- **Direct Revenue:** Scalable cash flow generated through participation fees for trader evaluation programs.
- **Capital Deployment:** Systematic value extraction from aggregated trader data used for cross-exchange arbitrage and hedging.
- **Profit Participation:** Upside captured through the performance of funded traders, aligning firm interests with trader success.
- **Strategic Expansion:** Potential for white-label deployment and institutional partnerships for third-party infrastructure use.

### Market Opportunity & Economics

- **Market Gap:** Addressing the lack of dominant platforms that combine execution infrastructure with capital access and trader acquisition.

- **Unit Economics:** User acquisition costs (approx. \$100-\$300) are strategically balanced against challenge fees (\$100-\$500), aiming for breakeven on initial entry.
- **Scalability:** Modular, cloud-based architecture designed to support thousands of concurrent traders and institutional-level deployment.
